Coastal Resilience Master Plan – Julia Chase

Sea Level is expected to rise by 2050 by 1-6 ft. We already have signs of flooding and erosion. Goal: Protect, accommodate, and relocate to preserve our coastal zones. Priority Projects:

1. La Jolla Shores- reconfigure the park, and back parking up to preserve the park along the shore.

2. Tourmaline Beach – Plan to increase public access and possibly locate a pedestrian pathway with

potential green space. Formalize paths to the beach for easy access.

3. Mission Beach – Create Dunes along the wall. Create a Perch Beach or elevated beach and realign the sea wall.

4. Ocean Beach – Dog Beach- Vegetated Dun along the beachfront with a pedestrian path set behind. (multiuse Path) Increase bathroom access.

5. Sunset Cliffs – The parking lot must be moved back off the cliff. Possibly change the 2-way street to a 1-way street at the south end with a separated bike path and pedestrian path adding designated crosswalks and lights.

Release of the PEIR Draft Plan will be in the next few weeks and then comments and public input will be open for 45 days.

Land Development Code Update- Liz Saidkhanian

Chapters 11-15 of SD Municipal Code will be updated. **Over 200 items will be considered**. The anticipated timeline is as follows.

Jan/Feb Draft amendments released, and draft overview video released.

Jan/April CPG review and public workshops including CPC & CPC subcommittee meetings May-July Public hearings

The public can submit language to suggest changes before public hearings. "If you don't like something, say something."

Budget Request to increase stipend for CPGs – This item included a lot of input from CPC

representatives. Many groups spend \$1,500 on election software and \$1,000 on Zoom and URLs. One suggested asking for a discounted rate from companies if we can streamline the structure. All CPGs contract with the same companies. Encanto paid \$1,000 on appeal and didn't get reimbursed after winning. I know Robin Kaufman suggested voting to not support the increase as it would be wise not to rock the boat with the city. After sitting in the meeting and listening to the unfortunate stories and struggles, I couldn't vote to deny the increase. Will the city award the money, most likely not but my vote was in favor of supporting CPC's across the city.
